
In May 2021, the piloting phase of the CLIL FOR YEC project took place at the Direzione Didattica Aldo Moro, in Terni.


The lessons were implemented in 10 classes, ranging from first to fifth grade. They were about: Citizenship education, Environmental education and Basic financial education.

The parents were actively involved in the activities.


